NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby directs the appropriate authorities of the Tohono O'odham Nation to use the Consumer Price Index as the formula for adjusting the fair market value of the rights granted in the easement in the renegotiations.

The foregoing resolution was passed by the Tohono O'odham Council on the $\underline{5th}$ day of November, 1987, at a meeting at which a quorum was present with a vote of $\underline{1,073.0}$ for; $\underline{221.0}$ against; $\underline{346.0}$ not voting; and $\underline{01}$ absent, pursuant to the powers vested in the Council by Section 1 (i)(1) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
