

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tuberculosis Control Program)

RES. NO. 40-87

1 WHEREAS, the Tohono O'Odham Nation has operated a Tuberculosis Control Program
2 to help prevent the spread of the disease through community education,
3 prevention, early detection, comprehensive regimens and careful
4 follow-up for individuals; and

5 WHEREAS, funding for the operation of the Tohono O'Odham Tuberculosis Control
6 Program has been provided in part through supplemental funding
7 sources; and

8 WHEREAS, the Tohono O'Odham Tuberculosis Control Program office desires to
9 continue the services it provides to TB susceptible patient's during
10 the next fiscal year; and

11 WHEREAS, the Tohono O'Odham Tuberculosis Control Program has received funding
12 from the Department of Health Services, State of Arizona for its
13 program.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
16 it does hereby approve the proposal for funding of the Tohono O'Odham
17 Tuberculosis Control Program from the Department of Health Services,
18 State of Arizona and that the duration of this contract will be from
19 July 01, 1987 through June 30, 1988 unless extended by mutual agree-
20 ment of both contracting parties.

22 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the
23 Tohono O'Odham Nation will not fund or operate the program in the
24 interim while negotiations are still being conducted and no executed
25 contract has been awarded by the Department of Health Services, State
26 of Arizona.

28 BE IT FURTHER RESOLVED that Josiah Moore, Chairman; Francisco Jose, Jr, Vice-
29 Chairman; or Rosita N. Ruiz, Acting Treasurer are hereby authorized
30 and directed to negotiate and execute any and all contracts, amend-
31 ments and documents necessary to secure funding for the operation of
32 the Tohono O'Odham Tuberculosis Control Program.

1 The foregoing resolution was passed by the Tohono O'odham Council on the 4th
2 day of February, 1987, at a meeting at which a quorum was present with a vote
3 of 1429.0 for; -0- against; -0- not voting; and 211.0 absent, pursuant to the
4 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
5 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
6 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
7 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
8 of June 18, 1934 (48 Stat. 984).
