WHEREAS, the Tohono O'odham Nation is presently operating the Water Distribu-1 tion Program under as P.L. 93-638 contract with the Bureau of 2 3 Reclamation; and WHEREAS, any amendments affecting the funding of the contract shall be 4 5 submitted for approval by the Tohono O'odham Legislative Council; and 6

WHEREAS, an amendment has been submitted by the Tohono O'odham Water Distribution Program for review and approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the amendment to the Tohono O'odham Water Distribution contract, as reflected in the attached budget.

BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and the Treasurer of the Tohono O'odham Nation are hereby authorized to negotiate and execute the contract and any amendments thereto for the duration of the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 5th day of November, 1987, at a meeting at which a quorum was present with a vote of 1,321.0 for; 117.0 against; 202.0 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1 (d)(2)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
