11 day of November, 1987, at a meeting at which a quorum was present with a vote
12 of 1349.5 for; 232.0 against; 58.5 not voting; and -02- absent, pursuant to
13 the powers vested in the Council by Section 3 of Article II and Article VI
14 Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the
Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
