

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Water Resources Contract Amendment)

RES. NO. 415-87

1 WHEREAS, Section 303 (B) (1) of Title II of P.L. 97-293, The Southern Arizona
2 Water Rights Settlement Act of 1982 authorized and directed that a
3 study be done to determine the availability and suitability of Water
4 Resources within the Tohono O'odham Nation; and
5 WHEREAS, the Tohono O'odham Nation has entered into a multi-year contract with
6 the Bureau of Indian Affairs; and
7 WHEREAS, an additional \$1.5 million has been allocated for the study of Water
8 Resources within the Tohono O'odham Nation; and
9
10 WHEREAS, any amendments affecting the funding or funding levels of the contract
11 shall be submitted for review and approval by the Tohono O'odham
12 Legislative Council.

13 NOW, THEREFORE, BE IT RESOLVED that the source of the transfer of the \$1.5
14 million shall be identified.

15 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council, the
16 Chairman, Vice-Chairman and Treasurer of the Tohono O'Odham Nation are
17 hereby authorized to negotiate and execute this contract and any
18 amendments affecting the funding or funding levels of this contract
19 shall be submitted for further prior approval by this Council.

21 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
22 day of November, 1987, at a meeting at which a quorum was present with a vote
23 of 1,053.5 for; 341.5 against; 245.0 not voting; and 02 absent, pursuant to the
24 powers vested in the Council by Section 1 (d)(3)(f) of Article VI of the
25 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
