WHEREAS, the Tohono O'Odham Nation is presently operating Juvenile Delinquency Prevention Services under an agreement with United Way of Tucson; and WHEREAS, such services for the youth have been successful and beneficial; and WHEREAS, the Tohono O'Odham Nation does desire to enter into an agreement for services during FY-88.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does support and authorize the Tohono O'Odham Nation to enter into an agreement with United Way of Tucson for Juvenile Delinquency Prevention Services.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the

Tohono O'Odham Nation will not fund or operate the program in the

interim while negotiations are still being conducted and no executed

contract has been awarded by the United Way of Tucson Agency.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that Josiah Moore, Chairman; Francisco Jose, Vice-Chairman; or Rosita N. Ruiz, Acting Treasurer of the Tohono O'Odham Nation are hereby authorized to negotiate and execute any and all contracts, amendments and documents necessary to secure funding for the continued operation of the Juvenile Delinquency Prevention Services.

The foregoing resolution was passed by the Tohono O'odham Council on the $\frac{4\text{th}}{4\text{day}}$ of $\frac{\text{February}}{1987}$, at a meeting at which a quorum was present with a vote of $\frac{1360.0}{1987}$ for; $\frac{1987}{1987}$ against; $\frac{69.0}{1987}$ not voting; and $\frac{211.0}{1988}$ absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
