

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Administrative Plan for Health Department)

RES. NO. 421-87

1 WHEREAS, Section 2 (a) of Article VII of the Constitution of the
2 Tohono O'Odham Nation mandates that the administration
3 and management of the government be in accordance with
4 an administrative plan adopted by the Legislative
5 Council; and

6 WHEREAS, the current Health Advisory Group, working with the
7 Health Department, has developed and proposed for
8 adoption the attached Administrative Plan which
9 establishes a Health Department under the direction of a
10 director, as well as a Health Board with certain
11 designated powers; and


12 WHEREAS, the Administrative Plan has been reviewed by the Health
13 and Human Services Committee & Rules Committee and comes
14 to the Council for review and action.

15 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby adopt
16 the attached Administrative Plan creating the Health
17 Department of the Tohono O'Odham Nation.

18 BE IT FURTHER RESOLVED that any resolutions and ordinances of the
19 Council the provisions of which are in conflict with the
20 herein adopted Administrative Plan are hereby repealed
21 and of no further force and effect.

22 The foregoing resolution was passed by the Tohono O'odham Council
23 on the 7th day of December, 1987, at a meeting at which a quorum
24 was present with a vote of 1,076.5 for; 505.0 against; 58.5 not
25 voting; and 01 absent; pursuant to the powers vested in the
26 Council by Section 1 (b) of Article VI and Section 2 (a) of
27 Article VII of the Constitution of the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
