

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescission of Resolution of 399-87)

RES. NO. 425-87

1 WHEREAS, the Tohono O'Odham Legislative Council enacted
2 Resolution No. 399-87 (Approval of San Lucy District
3 Budget and Approval of Loan or Loan Guarantee) on
4 November 3, 1987; and

5 WHEREAS, the Tohono O'Odham Legislative Council met on December
6 08, 1987 with invitations sent to the Nation's Chairman,
7 the Nation's Vice-Chairman and the Chairman of San Lucy
8 District to discuss and clarify the intent of Resolution
9 No. 399-87; and

10 WHEREAS, the Tohono O'Odham Legislative Council reviewed the
11 memorandums and letters in the absence of the Nation's
12 Chairman, the Vice-Chairman of the Nation and the San
13 Lucy District Chairman regarding Resolution No. 399-87
14 and deem it necessary to reconsider Resolution No. 399-
15 87.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
17 Council that it hereby rescinds Resolution No. 399-87
18 (Approval of San Lucy District Budget and approval of
19 Loan or Loan Guarantee).

20 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
21 Council will continue their discussion on the San Lucy
22 District Budget tomorrow (December 09, 1987).

23 The foregoing resolution was passed by the Tohono O'Odham Council
24 on the 8th. day of December, 1987, at a meeting at which a
25 quorum was present with a vote of 1429.0 for; 211.0 against; -0-
26 not voting; and 03 absent; pursuant to the powers vested in the
27 Council by Section 1 (d)(2)(3) of Article VI of the Constitution
28 of the Tohono O'Odham Nation on January 18, 1986, and approved by
29 the Acting Deputy Assistant Secretary - Indian Affairs
30 (Operations) on March 6, 1986, pursuant to Section 16 of the Act
31 of June 18, 1934 (48 Stat. 984).
