

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Application and Acceptance of FEMA VI Funds for Emergency Foods)

RES. NO. 427-87

1 WHEREAS, the United Way of Greater Tucson was awarded funds for  
2 emergency food and shelter through the Federal Emergency  
3 Management Agency (FEMA VI); and

4 WHEREAS, the United Way of Greater Tucson has made these funds  
5 available to organizations and agencies in the Pima  
6 County area which provide emergency food and shelter  
7 services; and

8 WHEREAS, the Tohono O'Odham Nation through the Tohono O'Odham  
9 Human Service Department does provide emergency food and  
10 shelter; and


11 WHEREAS, the Tohono O'Odham Nation does desire to apply for funds  
12 to provide emergency food for needy individuals and  
13 families.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
15 Council that it does authorize the Tohono O'Odham Human  
16 Service Department to apply to the United Way of Greater  
17 Tucson for FEMA VI funds to provide emergency food for  
18 needy individuals and families.

19 BE IT FURTHER RESOLVED that the Chairman, Vice Chairman or  
20 Treasurer of the Tohono O'Odham Nation are hereby  
21 authorized to negotiate and execute this contract and  
22 any amendments thereto for the duration of the contract  
23 providing however that any amendments affecting the  
24 funding or funding levels of this contract shall be  
25 submitted for further prior approval by this Council.

26 The foregoing resolution was passed by the Tohono O'Odham Council  
27 on the 8th. day of December, 1987, at a meeting at which a  
28 quorum was present with a vote of 1581.5 for; -0- against; 58.5  
29 not voting; and 02 absent; pursuant to the powers vested in the  
30 Council by Section 1 (d)(3)(f) of Article VI of the Constitution  
31 of the Tohono O'Odham Nation on January 18, 1986, and approved by  
32 the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984).
