

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Funding for mapping, sampling and drilling of Green-
back and Papago (O'odham) Mining Prospects)

RES. NO. 42-87

1 WHEREAS, The Tohono O'odham Legislative Council did pass Resolution No. 264-86
2 for mapping, sampling, and drilling of Greenback and Papago Mining
3 Properties; and

4 WHEREAS, funding is available within the Division of Energy and Minerals,
5 Bureau of Indian Affairs to complete the drilling of the Greenback
6 (Chuipo) and Papago (O'odham) prospects; and

7 WHEREAS, 25 CFR Section 271 of the Federal Regulations provides the mechanism
8 for Tribes to enter into P.L. 93-638 contracts or grants; and


9 WHEREAS, The Tohono O'odham Nation does desire to contract for geological
10 mapping, geochemical sampling and drilling to determine whether
11 or not these properties are good mineralized prospects.

12 NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'odham Legislative Council
13 does hereby authorize the Tohono O'odham Nation to enter into a
14 contract with the Bureau of Indian Affairs and that the duration
15 of the contract will be one (1) year.

16 BE IT FURTHER RESOLVED that Josiah Moore, Chairman; Francisco Jose, Jr. Vice-
17 Chairman; or Rosita N. Ruiz, Acting Treasurer of the Tohono O'odham
18 Nation are hereby authorized to negotiate and execute this contract
19 provided however, that any amendments affecting the funding or funding
20 levels of the contract shall be submitted for further approval by this
21 Council

22 The foregoing resolution was passed by the Tohono O'odham Council on the 4th
23 day of February, 1987, at a meeting at which a quorum was present with a vote
24 of 1010.5 for; 390.0 against; 239.5 not voting; and -0- absent, pursuant to the
25 powers vested in the Council by Section d (2) (3) and f of Article VI of the
26 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
27 on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
29 of June 18, 1934 (48 Stat. 984).
