

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tabling Plan to Renovate Building No. 50)

RES. NO. 428-87

1 WHEREAS, the Health and Human Services Committee did submit a
2 plan to renovate BIA Building No. 50 on behalf of the
3 Human Services Program; and

4 WHEREAS, the cost for renovating the building is estimated at
5 \$115,800.00; and

6 WHEREAS, Human Services Program has identified \$130,000.00 in
7 carry over monies which can be used to do such work; and

8 WHEREAS, the Tohono O'odham Legislative Council would like a
9 clarification on the source of the carry over [funds],
10 specifically the areas from which monies were not
11 utilized and identifying whether it is from services,
12 salaries or program operations.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legis-
14 lative Council does hereby table the request to approve
15 a plan to renovate Building No. 50.

16 BE IT FURTHER RESOLVED that a written report be submitted to the
17 Tohono O'odham Legislative Council. The document is to
18 reflect the following information regarding the
19 \$130,000.00 carry over monies:

- 20 1. Identification of line items where carry overs
21 occurred.
- 22 2. The dollar amount of each carry over per line item.
- 23 3. The amount of funds allocated for use for the eleven
(11) Districts.

24 The foregoing resolution was passed by the Tohono O'odham
25 Council on the 9th day of December, 1987, at a meeting at which
26 a quorum was present with a vote of 973.0 for; 509.0 against;
27 158.0 not voting; and 06 absent; pursuant to the powers vested in
28 the Council by Section 1 (d)(3) of Article VI of the Constitution
of the Tohono O'odham Nation on January 18, 1986, and approved by
the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
