

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(San Xavier District FY '88 Budget Amendment)

RES. NO. 429-87

1 WHEREAS, the San Xavier District Council has reviewed the amended  
2 budget for FY '88; and

3 WHEREAS, the San Xavier District Council did by Resolution #12-  
4 87-02 approve to amend their FY '88 budget by the amount  
5 of \$17,927.00; and

6 WHEREAS, the Tohono O'Odham Legislative Council has determined  
7 the need for an increase in the San Xavier District FY  
8 '88 budget to better serve its constituents.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
10 Legislative Council hereby approves the FY '88 budget  
11 amendment for San Xavier District.

12 BE IT FURTHER RESOLVED that the San Xavier District FY '88 Budget  
13 of \$107,205.00 is amended to \$188,132.00 increasing the  
14 budget amount by \$17,927.00.

15 The foregoing resolution was passed by the Tohono O'Odham Council  
16 on the 8th day of December, 1987, at a meeting at which a quorum  
17 was present with a vote of 1523.0 for; -0- against; 117.0 not  
18 voting; and 06 absent; pursuant to the powers vested in the  
19 Council by Section 1 (d)(3) of Article VI of the Constitution of  
20 the Tohono O'Odham Nation on January 18, 1986, and approved by  
21 the Acting Deputy Assistant Secretary - Indian Affairs  
22 (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
23 of June 18, 1934 (48 Stat. 984).




