1 WHEREAS, An application for enrollment as a member of the Tohono O'odham Nation

6 WHEREAS, The Enrollment Committee has reviewed the applications and has recom-  
7 mended that the applications be denied because the applicants failed  
8 to establish the following membership requirement(s): TOHONO O'ODHAM  
9 CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

10 WHEREAS, The applications have come on for hearing before this Council; and

11 WHEREAS, The Enrollment Committee did serve written notice of its recommen-  
12 dation to reject the applications and of this hearing, as required by  
13 Section 2, Article VI of the Enrollment Ordinance, upon the person(s)  
14 who filed the application(s) and such person(s) was not present at  
15 this hearing; and

17 WHEREAS, The Tohono O'odham Council has reviewed all of the evidence presented  
18 and from such evidence finds that the applicant(s) has failed to es-  
19 tablish the foregoing membership requirement(s).

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does here-  
21 by determine that the application(s) of:

23 for enrollment as a member of the Tohono O'odham Nation is hereby


26 BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall

30 of the Enrollment Ordinance.

The foregoing resolution was passed by the Tohono O'odham Council on the 10th day of December, 1987, at a meeting at which a quorum was present with a vote of 844.0 for; 558.0 against; 238.0 not voting; and 02 absent, pursuant to the powers vested in the Council by Article II and Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




