

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY-88 Title XX Grant-Child Day Care)

RES. NO. 43-87

1 WHEREAS, the Tohono O'Odham Nation has consistently supported the nurturance
2 of its young members by providing for their welfare through various
3 programs and services designed to meet their special needs;

4 WHEREAS, the Child Day Care Services Program has been successfully operated
5 through the Early Childhood Headstart Department and has served many
6 young Tohono O'Odham children; and

7 WHEREAS, the Tohono O'Odham Legislative Council is desirous of continuing this
8 program for the benefit of its young members; and

9 WHEREAS, the Tohono O'Odham Nation has previously applied for, and received
10 funding to operate the Child Day Care Services Program from the
11 Department of Economic Security, Block Grant Administration ; and

13 NOW, THEREFORE BE IT RESOLVED by the Tohono O'Odham Legislative Council that
14 it does hereby approve the proposed Contract for Title XX Child Day
15 Care Services and that the duration of this contract will be from
16 July 01, 1987 through June 30, 1988 unless extended by mutual agree-
17 ment of both contracting parties.

18 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the
19 Tohono O'Odham Nation will not fund or operate the program in the
20 interim while negotiations are still being conducted and no executed
21 contract has been awarded by the Department of Economic Security,
22 State of Arizona.

24 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that Josiah
25 Moore, Chairman; Francisco Jose, Vice-Chairman or Rosita N. Ruiz,
26 Acting Treasurer of the Tohono O'Odham Nation are hereby authorized to
27 negotiate and execute any and all contracts, amendments and
28 documents necessary to secure funding for the continued operation of
29 the Child Day Care Program.

31 The foregoing resolution was passed by the Tohono O'odham Council on the 4th
32 day of February, 1987, at a meeting at which a quorum was present with a vote
of 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the
powers vested in the Council by Section 1 (f) of Article VI of the Constitution
of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January

1 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
2 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).
