WHEREAS, on October 12, 1982, Public Law 97-293 (Southern Arizona Water Rights Settlement Act) was enacted into law and on October 11, 1983, the agreement between the United States and the Tohono O'odham (Nation), as required by the Act, was executed by the parties; and

- whereas, as mandated by the Act and Agreement, part of the cost for the on reservation Planning Costs for the San Xavier and Schuk Toak new Farm Development were to be allocated to the United States Government and part of these costs were to be allocated to the Nation; and
- WHEREAS, it is necessary that the Nation and the Bureau of Reclamation enter into an agreement that will determine the Allocation of Planning Costs based upon percentages of cost, the United States will pay and the percentage of cost the Nation will pay; and
- whereas, representatives from the Bureau of Reclamation and representatives of the Nation, including the Water Resource Committee, have, through negotiations, agreed on the percentages to be used in determining the Allocation of Planning Costs, which is set forth in the proposed agreement attached herein, which costs is made apart hereof entitled agreement between the Bureau of Reclamation and the Tohono O'odham Nation; and
- whereas, the Water Resources Committee and other representatives of the Nation involved in the negotiations with the Bureau of Reclamation believe that the percentages to be used to determine the Allocation of Cost between the Nation and the United States are fair and equitable and recommend the Council approve the Agreement attached hereto.

NOW, THEREFORE, BE IT RESOLVED that the percentages set forth in the attached agreement to be used for the Allocation of Planning Cost between the United States and the Nation, as mandated by Public Law 97-293 in the agreement executed hereunder, are hereby approved and the Chairman or Vice Chairman of the Nation is hereby authorized to execute the Agreement attached hereto and made a part hereof.

BE IT FURTHER RESOLVED the Allocation on the Nation's Planning

Cost previously incurred due to the implementation of

Public Law 97-293 be paid as soon as practicable from

Public Law 97-293 Trust Income.

The foregoing resolution was passed by the Tohono O'odham Council on the 10th day of December, 1987, at a meeting at which a quorum was present with a vote of 1,480.5 for; 101.0 against; 58.5 not voting; and 02 absent; pursuant to the powers vested in the Council by Section 1 d (2) of Article VI of the Constitution of the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
