WHEREAS, the Tohono O'Odham Legislative Council did by Resolution
No. 425-87 rescind Resolution No. 399-87 (Approval of
San Lucy District Budget and approval of Loan or Loan
Guarantee); and

WHEREAS, upon presentation of Resolution No. 425-87 to the Chairman of the Tohono O'Odham Nation he did disapprove thereof and returning it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Nation; and

WHEREAS, the Council has reviewed the Chairman's objections and after consideration again voted to pass Resolution No. 425-87.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby override the Chairman's veto of Resolution No. 425-87, by a vote of two-thirds (2/3) of the votes cast 1,094.

The foregoing resolution was presented to the Tohono O'Odham Council on the 14th day of 1987, at a meeting at which a quorum was present and by a vote of 1555.0 for; 1985.0 against; 1985.0 not voting; and 1985.0 absent, did override the Chairman's veto of Resolution No. 1985.0 pursuant to the powers vested in the Council by Section 1985.0 of Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 181.0 1986 and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 1985.0 pursuant to Section 160.0 of the Act of June 181.0 1986, pursuant to Section 160.0 of the Act of June 181.0 1986 (48 Stat.)
