

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override veto of Resolution No. 425-87)

RES. NO. 442-87

1 WHEREAS, the Tohono O'Odham Legislative Council did by Resolution
2 No. 425-87 rescind Resolution No. 399-87 (Approval of
3 San Lucy District Budget and approval of Loan or Loan
4 Guarantee); and

5 WHEREAS, upon presentation of Resolution No. 425-87 to the
6 Chairman of the Tohono O'Odham Nation he did disapprove
7 thereof and returning it to the Council with his
8 objections in accordance with the provisions of Article
9 VII, Section 5 of the Constitution of the Nation; and

10 WHEREAS, the Council has reviewed the Chairman's objections and
11 after consideration again voted to pass Resolution No.
12 425-87.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
14 Legislative Council does hereby override the Chairman's
15 veto of Resolution No. 425-87, by a vote of two-thirds
16 (2/3) of the votes cast 1,094.


17 The foregoing resolution was presented to the Tohono O'Odham
18 Council on the 14th day of December, 1987, at a meeting at which
19 a quorum was present and by a vote of 1555.0 for; 85.0 against; 0
20 not voting; and 03 absent, did override the Chairman's veto of
21 Resolution No. 425-87, pursuant to the powers vested in the
22 Council by Section 5 of Article VII of the Constitution of the
23 Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
24 January 18, 1986 and approved by the Acting Deputy Assistant
25 Secretary - Indian Affairs (Operations) on March 6, 1986,
26 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
27 984).
