

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL  
(Tabling the San Lucy District Budget)

LEGIS. ORDER NO. 443-87

1 WHEREAS, the Tohono O'odham Legislative Council did rescind  
2 Resolution No. 399-87, "Approval of San Lucy District FY  
3 88 Budget and Approval of Loan or Loan Guarantee"; and

4 WHEREAS, said Resolution was vetoed by the Nation's Chairman  
5 Enos J. Francisco, Jr.; and

6 WHEREAS, the Tohono O'odham Legislative Council did override said  
7 resolution; and

8 WHEREAS, the Tohono O'odham Legislative Council did continue  
9 discussing the San Lucy District Budget.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
11 Council that the issue of San Lucy be referred back to  
12 the Budget and Finance Committee.

13 BE IT FURTHER RESOLVED that the matter of the San Lucy District  
14 utilizing funds from P.L. 99-503 also be referred back  
15 to the Commerce Committee and the Budget and Finance  
16 Committee.

17 BE IT FURTHER RESOLVED that the San Lucy District Budget be  
18 brought back to Council on Friday, December 18, 1987.

19 The foregoing Legislative Order was passed by the Tohono O'odham  
20 Council on the 14th day of December, 1987, at a meeting at which  
21 a quorum was present with a vote of 1099.0 for; 295.5 against;  
22 245.5 not voting; and 03 absent; pursuant to the powers vested  
23 in the Council by Section 1 (a) of Article VI of the Constitution  
24 of the Tohono O'odham Nation on January 18, 1986, and approved by  
25 the Acting Deputy Assistant Secretary - Indian Affairs  
26 (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
27 of June 18, 1934 (48 Stat. 984).
