

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Referring San Lucy for Committees' Reviews)

RES. NO. 444-87

1 WHEREAS, the Tohono O'odham Legislative Council has tabled the
2 review and approval of San Lucy District Budget; and

3 WHEREAS, \$473,213.75 of the Nation's funds was transferred to the
4 San Lucy District Account at the direction of the
5 Nation's Chairman; and

6 WHEREAS, the Tohono O'odham Legislative Council did not authorize
7 such transfer in the amount of \$473,213.75; and

8 WHEREAS, said funds have not been fully identified as excess
9 monies nor have been reflected as excess projected funds
10 with all Nation's obligations cleared and all
11 liabilities paid in full.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
13 Council that in presenting their budget for review
14 before the Budget and Finance Committee and the
15 Legislative Council, San Lucy District provide a full
16 accounting of funds in the amount of \$473,213.75
17 and that it be done in writing.

18 The foregoing resolution was passed by the Tohono O'odham Council
19 on the 14th day of December, 1987, at a meeting at which a quorum
20 was present with a vote of 1555.0 for; 42.5 against; 42.5 not
21 voting; and 03 absent; pursuant to the powers vested in the
22 Council by Section 1 (a) of Article VI of the Constitution of the
23 Tohono O'odham Nation on January 18, 1986, and approved by the
24 Acting Deputy Assistant Secretary - Indian Affairs (Operations)
25 on March 6, 1986, pursuant to Section 16 of the Act of June 18,
26 1934 (48 Stat. 984).
