RES. NO. 445-87

1 WHEREAS, the Tohono O'Odham Legislative Council did appropriate  
2 and disperse \$100,000.00 per district for the express  
3 purpose of economic development; and

4 WHEREAS, the Schuk Toak District Council on November 21, 1987 by  
5 District Resolution No. 113-87 (attached) request that  
6 the full amount of \$100,000.00 be allocated to the  
7 District.


8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
9 Legislative Council hereby disperses the economic  
10 development allocation in the amount of \$100,000.00 for  
11 the Schuk Toak District.

12 BE IT FURTHER RESOLVED that any plans or proposals utilizing this  
13 allocation is subject to the review and recommendation  
14 of the Budget & Finance and Commerce Committee.

15 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative  
16 Council's approval is mandatory prior to the  
17 implementation of such plan and expenditure of said  
18 funds.


19 The foregoing resolution was passed by the Tohono O'odham Council  
20 on the 14th day of December, 1987, at a meeting at which a quorum  
21 was present with a vote of 1333.0 for; 190.0 against; 117.0 not  
22 voting; and 03 absent; pursuant to the powers vested in the  
23 Council by Section 1 (d)(2) of Article VI of the Constitution of  
24 the Tohono O'odham Nation on January 18, 1986, and approved by  
25 the Acting Deputy Assistant Secretary - Indian Affairs  
26 (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
27 of June 18, 1934 (48 Stat. 984).
