2 did approve by District Resolution No. 915-87, the FY
3 '88 budget in the amount of \$174,332.00; and

4 WHEREAS, the Schuk Toak District Council requests the Legislative
5 Council to ratify the budget; and

6 WHEREAS, the budgeted amount, upon ratification be allocated from
7 the Tribal IIM Accounts to be expended in accordance
8 with the attached budget.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
10 Legislative Council hereby approves the attached FY '88
11 Budget for Schuk Toak District in the amount of
12 \$174,332.00 .


13 The foregoing resolution was passed by the Tohono O'odham Council

21 of June 18, 1934 (48 Stat. 984).


