

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Lease to Papago Oasis Enterprises)

RES. NO. 447-87

1 WHEREAS, this Council did by Ordinance No. 2-84 grant to Alan  
2 Garcia, Jr. and Austin Nunez, two members of the Nation,  
3 a charter for Papago Oasis Enterprises, Inc., a tribally  
4 chartered corporation, and did grant to Papago Oasis  
5 Enterprises a license to build, establish and operate a  
6 cable television facility in Sells; and

7 WHEREAS, Papago Oasis Enterprises proposes to establish a "head  
8 end" electronic complex and business office for such  
9 facility in Sells upon land traditionally occupied by  
10 the Garcia family; and

11 WHEREAS, the Garcia family and the Sells District Council have  
12 approved the locations and use of the land for such  
13 purposes; and

14 WHEREAS, the Garcia family - through making no claim of ownership  
15 to the land by reason of its traditional occupancy  
16 thereof - requests that no greater consideration, in the  
17 form of lease payments, should be paid therefor by  
18 Papago Oasis Enterprises than the nominal consideration  
19 set out in section IV of the attached lease; and

20 WHEREAS, the Commerce Committee of the Council has reviewed the  
21 attached lease and recommends approval and execution  
22 thereof.

23 NOW, THEREFORE, BE IT RESOLVED that the Council approves and  
24 authorizes and directs the Chairman and other  
25 appropriate officers of the Tohono O'Odham Nation to  
26 execute the attached lease to Papago Oasis Enterprises  
27 on behalf of the Tohono O'Odham Nation.

28 The foregoing resolution was passed by the Tohono O'odham Council  
29 on the 14th day of December, 1987, at a meeting at which a quorum  
30 was present with a vote of 1640.0 for; -0- against; -0- not  
31 voting; and 03 absent; pursuant to the powers vested in the  
32 Council by Section 1 (i) and Section 2 (d) of Article VI of the  
Constitution of the Tohono O'odham Nation on January 18, 1986,  
and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).
