## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Lease to Papago Oasis Enterprises)

RES. NO. 447-87

- WHEREAS, this Council did by Ordinance No. 2-84 grant to Alan Garcia, Jr. and Austin Nunez, two members of the Nation, a charter for Papago Oasis Enterprises, Inc., a tribally chartered corporation, and did grant to Papago Oasis Enterprises a license to build, establish and operate a cable television facility in Sells; and
- whereas, Papago Oasis Enterprises proposes to establish a "head end" electronic complex and business office for such facility in Sells upon land traditionally occupied by the Garcia family; and
- WHEREAS, the Garcia family and the Sells District Council have approved the locations and use of the land for such purposes; and
- whereas, the Garcia family through making no claim of ownership to the land by reason of its traditional occupancy thereof requests that no greater consideration, in the form of lease payments, should be paid therefor by Papago Oasis Enterprises than the nominal consideration set out in section IV of the attached lease; and
- WHEREAS, the Commerce Committee of the Council has reviewed the attached lease and recommends approval and execution thereof.
- NOW, THEREFORE, BE IT RESOLVED that the Council approves and authorizes and directs the Chairman and other appropriate officers of the Tohono O'Odham Nation to execute the attached lease to Papago Oasis Enterprises on behalf of the Tohono O'Odham Nation.

The foregoing resolution was passed by the Tohono O'odham Council on the 14th day of December, 1987, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and 03 absent; pursuant to the powers vested in the Council by Section 1 (i) and Section 2 (d) of Article VI of the Constitution of the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
