

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Administration, Children, Youth and Families)

RES. NO. 44-87

1 WHEREAS, the Tohono O'odham Nation has operated successfully a Headstart, Early
2 Childhood and Day Care program for its young members; and

3 WHEREAS, funding for the operation of these programs has depended in large on
4 meritorious proposals by the Tohono O'odham Nation to various funding
5 agencies designed to fund programs oriented toward children; and

6 WHEREAS, The Department of Economic Security through the Administration for
7 Children, Youth and Families provides funds for certain eligible
8 services; and

10 WHEREAS, The Tohono O'odham Nation is desirous of seeking supplemental funds
11 from the Department of Economic Security to continue operation of its
12 Day Care Programs;

13 WHEREAS, all of the child-oriented programs have proven beneficial and valuable
14 to the Tohono O'odham, especially its young members;

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does hereby
16 approve the proposal to the Department of Economic Security, Admin-
17 istration for Children, Youth and Families for funding in the form of
18 reimbursement for the continued operation of the Day Care Services
19 program;

21 BE IT FURTHER RESOLVED by the Tohono O'Odham Council that Josiah Moore,
22 Chairman; Francisco Jose, Vice- Chairman or Rosita N. Ruiz, Acting
23 Treasurer of the Tohono O'Odham Nation are authorized and to
24 negotiate and execute any and all contracts, amendments and documents
25 necessary to secure funding from the Administration for Children,
26 Youth and Families.

28 The foregoing resolution was passed by the Tohono O'odham Council on the 4th
29 day of February, 1987, at a meeting at which a quorum was present with a vote
30 of 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the
31 powers vested in the Council by Section 1 (f) of Article VI of the Constitution
32 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).
