5 District to continue serving the aged and disadvantaged
6 members of the Sells District.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
8 Council that it hereby adopts the proposed budget
9 submitted by Sells District.

10 The foregoing resolution was passed by the Tohono O'odham Council
11 on the 14th day of December, 1987, at a meeting at which a quorum
12 was present with a vote of 1640.0 for; -0- against; -0- not
13 voting; and 03 absent; pursuant to the powers vested in the
14 Council by Section 1 (d)(3) of Article VI of the Constitution of
15 the Tohono O'odham Nation on January 18, 1986, and approved by
16 the Acting Deputy Assistant Secretary - Indian Affairs
17 (Operations) on March 6, 1986, pursuant to Section 16 of the Act
18 of June 18, 1934 (48 Stat. 984).
