1 WHEREAS, the Legislative Housing Committee did request to have
2 the HIP (Housing Improvement Program) Contract on the
3 Tohono O'odham Legislative Council agenda; and

4 WHEREAS, the Chairman of the Housing Committee did review
5 correspondence from the Bureau of Indian Affairs with
6 attachments addressed to Wayne Chico, Director, Tohono
7 O'odham Housing Authority in reference to the Housing
8 Improvement Program for FY '87.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
10 Legislative Council requests the Executive Director of
11 the Housing Authority to respond in writing to the
12 Tohono O'odham Legislative Council on the issues brought
13 out on the December 4, 1987, memo from BIA at the Next
14 General Session.


15 The foregoing resolution was passed by the Tohono O'odham Council

22 on March 6, 1986, pursuant to Section 16 of the Act of June 18,
23 1934 (48 Stat. 984).


