

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Requiring Return of Funds Advanced to San Lucy District)

RES. NO. 452-87

1 WHEREAS, the Legislative Council did by Resolution No. 450-87
2 authorize the expenditure by the San Lucy District
3 Council of funds authorized pursuant to P. L. 99-503;
4 and

5 WHEREAS, the Legislative Council is concerned that the District
6 Council does not have in place sufficient financial,
7 personnel and contract control systems necessary to
8 assure proper expenditures of P. L. 99-503 settlement
9 funds.

10 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that
11 the District Council shall return to the Nation, within
12 five (5) working days of the effective date of this
13 Resolution, all unexpended funds previously advanced to
14 the District pursuant to Resolution No. 399-87,
15 together with any interest accrued thereon, which funds
16 and accrued interest shall be expended for the benefit
17 of the San Lucy District pursuant to authorizations
18 contained in Resolution No. 450-87.

19 BE IT FURTHER RESOLVED that in the event the San Lucy District
20 fails to provide this Council with the verified
21 accounting required by Resolution No. 450-87 within
22 thirty (30) days of the effective date of Resolution No.
23 450-87, or fails, within five (5) working days of the
24 effective date of this resolution, to return to the
25 Nation the unexpended funds as required hereinabove,
26 any authorization contained in Resolution No. 450-87 to
27 expend funds advanced to the District pursuant to
28 Resolution No. 399-87 shall terminate and the District
29 is ordered not to expend any such funds thereafter.

30 The foregoing resolution was passed by the Tohono O'odham
31 Council on the 18th day of December, 1987, at a meeting at which
a quorum was present with a vote of 1,386.5 for; 253.5 against;
-0- not voting; and 03 absent; pursuant to the powers vested in

the Council by Section 1 (d) of Article VI of the Constitution of the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
