

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Judges of the Tohono O'Odham Courts)

RES. NO. 51-87

1 WHEREAS, this Council is by Section 4 of Article VIII of the Constitution of
2 the Tohono O'Odham Nation charged with duty of appointing six judges
3 of the Tohono O'Odham Courts; and

4 WHEREAS, this Council has by Resolution No. 566-86 determined that the FY '87
5 budget for the Judiciary of the Tohono O'Odham Nation allows for the
6 appointment of only three full time judges and therefore requires that
7 the remaining three judges be appointed to part time positions; and

8 WHEREAS, this Council did by said resolution appoint three full time judges,
9 effective February 1, 1987, and the Judiciary Committee has recom-
10 mended the appointment forthwith of the following named applicants
11 to part time positions as judges of the Tohono O'Odham Courts, to be
12 compensated at the rate of \$150 per day, for the following terms,
13 namely:

15 Ned Norris, 6 years;
16 Evelyn Juan, 4 years;
17 Phyllis Cachora, 2 years; and

18 WHEREAS, this Council approves of the Judiciary Committee's recommendation.

19 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby determine
20 that the following named persons are qualified by temperament,
21 education and experience to be appointed as part time judges of the
22 Tohono O'Odham Courts, and the Council does hereby appoint them forth-
23 with upon the effective date of this resolution as such part time
24 judges, to be compensated at the rate of \$150 per day, for the terms
25 set forth next to their respective names, namely:

27 Ned Norris, 6 years
28 Evelyn Juan, 4 years
Phyllis Cachora, 2 years.

29 The foregoing resolution was passed by the Tohono O'odham Council on the 05th
30 day of February, 1987, at a meeting at which a quorum was present with a vote
31 of 1030.5 for; 417.0 against; 192.5 not voting; and 01 absent, pursuant to the
32 powers vested in the Council by Section 1 (a) and (b) of Article VI and Section
4 of Article VIII of the Constitution of the Tohono O'odham Nation, adopted by
the Tohono O'odham Nation on January 18, 1986, and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
