RES. NO. 52-87

WHEREAS, the Bureau of Indian Affairs (BIA) and Indian Health Service (IHS)

were mandated by the Omnibus Drug Act of 1986 to enter into Memoran
dum of Agreement (MOA) to coordinate drug and alcohol abuse prevention

activities; and

WHEREAS, the Tohono O'Odham Legislative Council passed Resolution No. 16-87 indicating that the proposed MOA was insufficient and that the Tohono O'Odham Nation intended to actively participate in the development of the MOA.

NOW, THEREFORE, BE IT RESOLVED that the following comments developed by the

Tohono O'Odham Tribal Coordinating Committee be adopted as official

comments of the Tohono O'Odham Nation in regards to the development of

the Memorandum Agreement between the Bureau of Indian Affairs and the

Indian Health Service.

BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council urges the inclusion of these comments to insure tribal participation and leader-ship in alcohol and drug abuse prevention activities.

The foregoing resolution was passed by the Tohono O'odham Council on the  $\underline{5th}$  day of  $\underline{February}$ ,  $\underline{1987}$ , at a meeting at which a quorum was present with a vote of  $\underline{1518.5}$  for;  $\underline{-0}$ - against;  $\underline{121.5}$  not voting; and  $\underline{01}$  absent, pursuant to the powers vested in the Council by Section  $\underline{1}$  (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
