

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(CDBG - Schuk Toak)

RES. NO. 55-87

1 WHEREAS, the Tohono O'Odham Nation did solicit the participation of the eleven
2 political districts of the Tohono O'Odham Reservation for priority
3 needs for their respective districts; and


4 WHEREAS, the Tohono O'Odham Nation did receive a proposal from Schuk Toak
5 District for a prospective project, namely: Schuk Toak District
6 Comobabi Community Water Project; and

7 WHEREAS, the Tohono O'Odham Legislative Council had determined it is in the
8 best interest to apply for CDBG Program funds for the purpose of the
9 above projects.


11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
12 it hereby directs and authorizes the Chairman, Vice-Chairman to
13 consult with and negotiate for CDBG funding and to execute any and all
14 contracts and legal documents and any amendments thereto which may be
15 necessary to implement the project.

17 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
18 day of February, 1987, at a meeting at which a quorum was present with a vote
19 of 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the
20 powers vested in the Council by Section 1 (j) of Article VI of the Constitu-
21 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
22 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
24 of June 18, 1934 (48 Stat. 984).
