

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Citizen Participation Certification)

RES. NO. 57-87

1 WHEREAS, the Tohono O'Odham Nation has submitted an application for a grant  
2 to fund certain eligible Indian Community Development Block Grant  
3 Program activities and in connection with such application resolve and  
4 made certain assurances.

5 NOW, THEREFORE, BE IT RESOLVED THAT prior to the submission of its application,  
6 the governing body of the Tohono O'Odham Nation has provided tribal  
7 citizens through their Council Representatives especially those living  
8 in areas where activities are proposed or ongoing with adequate infor-  
9 mation concerning the amount of funds available for proposed community  
10 development and housing activities the range of activites that may be  
11 assisted, and other important program requirements and solicited their  
12 views and participation.


14 Followed traditional Tribal means of citizen involvement through  
15 District Council meetings and Tohono O'Odham Legislative Council  
16 meetings, opportunity to articulate needs, express preferences  
17 about proposed community development and housing activities, assist in  
18 the selection of district priorities, and otherwise participate in the  
19 development of the application.

21 (No part of this paragraph shall be construed to restrict the respons-  
22 ibility and authority of the applicant for development of the  
23 application and the execution of its Community Development Block Grant  
24 Program. Accordingly, the citizen participation requirements of this  
25 paragraph do not include concurrence by any person or group involved  
26 in citizen participation in making final determinations concerning the  
27 findings and contents of the application. The sole responsibility and  
28 authority to make such final determinations rest exclusively with the  
29 Tohono O'Odham Legislative Council.

31 The foregoing resolution was passed by the Tohono O'odham Council on the 6th  
32 day of February, 1987, at a meeting at which a quorum was present with a vote  
of 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the  
powers vested in the Council by Section 1 (b) of Article VI of the

1 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
2 on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
3 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
4 of June 18, 1934 (48 Stat. 984).
