

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(O'Odham Construction Contracts)

RES. NO. 58-87

1 WHEREAS, the Tohono O'Odham Nation has received a grant of \$1,135,000.00, Tele-
2 phone Improvement Project CDBG No. B-85-SR-04-0931, wherein PTUA is
3 the sub-grantee for the addition and alteration of the telephone
4 facilities operated by PTUA which includes \$270,000.00 for the con-
5 struction and alteration of buildings; and

6 WHEREAS, O'Odham Construction and Materials Co. did submit a low bid of
7 \$213,000.00 to PTUA for the construction and alteration of buildings;


10 WHEREAS, PTUA prepares to enter into other contracts with O'Odham Construction
11 for concrete and related work in the construction and erection of a
12 warehouse building funded under REA loans; and

13 WHEREAS, it will be of benefit to this Nation that O'Odham Construction be
14 authorized to enter into such contracts with PTUA for the construction
15 and alteration of PTUA's buildings and warehouse.

16 NOW, THEREFORE, BE IT RESOLVED that it does hereby authorize O'Odham
17 Construction to enter into contracts with PTUA for the construction
18 and alteration of PTUA's buildings and warehouse, and does hereby
19 authorize the Vice-Chairman and other appropriate officers of the
20 Nation to negotiate and execute such contracts, and any amendments
21 thereto on behalf of O'Odham Construction.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
24 day of February, 1987, at a meeting at which a quorum was present with a vote
25 of 1102.0 for; 538.0 against; -0- not voting; and -0- absent, pursuant to the
26 powers vested in the Council by Section 1 (b) and (e) of Article VI of the Con-
27 stitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
28 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
29 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
30 of June 18, 1934 (48 Stat. 984).
