8	WHEREAS,	the Tohono O'Odham Nation is the owner and holder of 70,000 shares, or						
10		70 percent of the common stock of Papago Chemicals, Inc; and						
11	WHEREAS,	the sale of chemicals is no longer profitable for Papago Chemicals,						
12		Inc; and						
13	WHEREAS,	there are retained earnings held by Papago Chemicals , Inc.; and						
14	WHEREAS,	Phillips Petroleum Company, as a 30 percent shareholder in Papago						
15		Chemicals, Inc. has consented to the dissolution of Papago Chemicals,

18	WHEREAS,	it is the recommendation of the board of directors of Papago						
19		Chemicals, Inc. that the corporation be dissolved and its assets						
20		liquidated and dispensed to the shareholders of the corporation.
