

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override veto on Resolution No. 64-87)

RES. NO. 67-87

1 WHEREAS, the Tohono O'Odham Legislative Council did by Resolution No. 64-87
2 did approve the Commerce Committee Contract with Daniel S. Press; and
3 WHEREAS, upon presentation of Resolution No. 64-87 to the Chairman of the
4 Tohono O'Odham Nation he did disapprove thereof and returning it to
5 the Council with his objections in accordance with the provisions of
6 Article VII, Section 5 of Constitution of the Nation; and
7
8 WHEREAS, the Council has reviewed the Chairman's objections and after consider-
9 ation again voted to pass Resolution No. 64-87.
10 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby over-
11 ride the Chairman's veto of Resolution No. 64-87, by a vote of two-
12 thirds (2/3) of the votes cast.

13 The foregoing resolution was presented to the Tohono O'odham Council on the 2nd
14 day of March, 1987, at a meeting at which a quorum was present and, by a vote
15 of 521.5 for; 1118.5 against; -0- not voting; and 05 absent, failed to override
16 the Chairman's veto of Resolution No. 64-87 pursuant to the powers vested in
17 the Council by Section 5 of Article VII of the Constitution of the Tohono
18 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and
19 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations)
20 on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
21 984).
