

1 Resolution of the Tohono O'Odham Nation Legislative Council  
2 Workfare Demonstration Project

RES. NO. 73-87

3 Whereas: The Department of the Interior has proposed to Congress the  
4 allocation of funds for the purpose of funding self-assistance  
5 programs such as "workfare" for Indian Tribes: and

6 Whereas: the Tohono O'odham Nation recognizes the needs for a program  
7 which will foster economic independence and self sufficiency  
8 in individuals and families; and

9 Whereas: the Tohono O'Odham Human Service Department has primary  
10 responsibility over the financial assistance program and the  
11 Tribal Work Experience Program; and

12 Whereas: the Tohono O'Odham Human Service Department proposes to apply  
13 for funds to develop and implement a Workfare Demonstration  
14 Project which will foster economic independence and self  
15 sufficiency for general assistance recipients; and

16 Whereas: the nature of the Workfare Demonstration Project requires  
17 a co-ordinated effort between tribal, state and federal  
18 agencies; and

19 Whereas: the Tohono O'Odham Nation is eligible to apply for funds for  
20 a Workfare Demonstration Project.

21 NOW THEREFORE BE IT RESOLVED BY the Tohono O'Odham Legislative Council  
22 that it does hereby approve and authorize the Tohono O'Odham  
23 Human Service Department to apply for funds for a Workfare  
24 Demonstration Project.

1 The foregoing resolution was passed by the Tohono O'odham Council on the 2nd  
2 day of March, 1987, at a meeting at which a quorum was present with a vote of  
3 1281.5 for; -0- against; 117.0 not voting; and 241.5 absent, pursuant to the  
4 powers vested in the Council by Section 1 (j) of Article VI of the Constitu-  
5 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
6 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
7 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
8 of June 18, 1934 (48 Stat. 984).
