1	WHEREAS, The Tohono O'odham people duly adopted a new constitution approving							
2	the separation of the Tohono O'odham Nation's government into three							
3	(3) separate but equal branches of government; and							
4	WHEREAS, The Judicial Branch is the last of the three (3) branches to begin							
5	operating as a branch of government; and							
6	WHEREAS, Inadequate funding has greatly hindered the timely transition of the							
7	Judicial Branch and unless additional funds are obtained, the mandate							
8	of the constitution will be frustrated; and							
9	WHEREAS, The current base level of funding provided through P.L. 93-638							
10								
11	Judicial Services is barely sufficient to keep the Judicial System in							
12	operation and has required the Tohono O'odham Nation to provide							
13	supplemental funds; and							
14	WHEREAS, The Judiciary has provided adequate documented support to justify the							
15	request for additional funds.							
16	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that							
17 18	it does hereby request the Honorable Congress to direct the B.I.A.							
19	to identify additional funds to increase the base level of funding							
20	to enable the Tohono O'odham Judiciary to develop under the new							
21	constitution.							
22	The foregoing resolution was passed by the Tohono O'odham Council on the 2nd							
23	day of March, 1987, at a meeting at which a quorum was present with a vote of $1523.0$ for; $117.0$ against; $-0$ - not voting; and $06$ absent, pursuant to the powers vested in the Council by Section 1 (j) of Article VI of the Constitution
