

RESOLUTION OF THE TOHONO O'ODHAM COUNCIL  
(Papago Farming Authority - Loan Guaranty)

RES. NO. 81-87

1 WHEREAS, this Council did by Resolution No. 218-86 authorize the Chairman  
2 and Treasurer of this Nation to execute a Continuing Guaranty  
3 wherein the Tohono O'odham Nation did collateralize up to \$400,000.00  
4 of a 1986 crop loan from Producers Cotton Oil Company to the Papago  
5 Farming Authority with the condition that the guaranty be cancelled  
6 when the crop loan is paid in full; and

7  
8 WHEREAS, the Authority has paid off the crop loan from Producers Cotton  
9 Oil Company and the guaranty executed by the Nation has been  
10 cancelled; and


11 WHEREAS, the Authority has asked the Nation to collateralize a new loan of up  
12 to \$100,000 from Producers Cotton Oil Company to be repaid by the  
13 Authority from its 1987 crops.

14 NOW, THEREFORE, BE IT RESOLVED that the Chairman and other appropriate officers  
15 of this Nation are authorized to execute a new Continuing Guaranty  
16 wherein this Nation will collateralize up to \$100,000.00, a 1987 crop  
17 loan from Producers Cotton Oil Company to the Papago Farming  
18 Authority .

20 BE IT FURTHER RESOLVED that as a condition that the new Continuing Guaranty for  
21 \$100,000 shall continue in full force and effect until midnight  
22 March 3rd, 1988.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 3rd.  
24 day of March, 1987, at a meeting at which a quorum was present with a vote of  
25 1640.0 for; -0- against; -0- not voting; and 03 absent, pursuant to the powers  
26 vested in the Council by Section 1(d) of Article VI of the Constitution of the  
27 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).
