3 Sharing budget in the amount of \$13,401.00; and


4 WHEREAS, the Chukut Kuk District has sufficient funds in its Revenue Sharing

8 approves of same.



11 it does hereby approve the attached FY 87 Revenue Sharing budget in  
12 the amount of \$13,401.00 of the Chukut Kuk District and authorize  
13 expenditures in accordance therewith.

15 The foregoing resolution was passed by the Tohono O'odham Council on the 5th  
16 day of March, 1987, at a meeting at which a quorum was present with a vote of  
17 1581.5 for; -0- against; 58.5 not voting; and 04 absent, pursuant to the powers  
18 vested in the Council by Section 1 (d) of Article VI of the Constitution of the  
19 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).
