(Enrollment - January)

1 WHEREAS, the Tohono O'Odham Council has reviewed the  
2 recommendations of the Enrollment Committee in  
3 accordance with Section 1 of Article VIII of the  
4 Enrollment Ordinance, Ordinance No. 05-81, and has made  
5 a final determination that the application of the

16 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that  
17 the above named applicants are eligible for enrollment  
18 as members of the Tohono O'Odham Nation under Section  
19 1(a) or (b) of Article II of the Constitution of the  
20 Tohono O'Odham Nation, and that their applications are  
21 approved, as herein above indicated.

22 BE IT FURTHER RESOLVED that the Chairman and other appropriate  
23 officers of the Tohono O'Odham Nation reduce this final  
24 determination in writing regarding each of the foregoing  
25 applications for enrollment in accordance with Section 3  
26 (c) of Article III of the Enrollment Ordinance; give  
27 notice of this Council's determination in accordance  
28 with Section 4 of Article III of the Enrollment  
29 Ordinance; and place the names of each applicant upon  
30 the membership roll of the Tohono O'Odham Nation in  
31 accordance with Article V of the Enrollment Ordinance.

32 The foregoing Resolution was passed by the Tohono O'Odham Council  
on the 3rd. day of January, 1989 at a meeting at which a quorum  
was present with a vote of 1,449.0 for; -0- against; 63.0 not  
voting; and 128.0 absent, pursuant to the powers vested in the  
Council by Section 1 of Article II and of Section 1 (h) of  
Article VI of the Constitution of the Tohono O'Odham Nation,

adopted by the Tohono O'Odham Nation on January 18, 1986 and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
