- WHEREAS, the basis for rejecting the Administrative Plan is because it does not contain enough details to clarify the manner in which the government is to be administered and the failure on the part of the Chairman of the Tohono O'Odham Nation to appear before the Legislative Council to present the Administrative Plan; and
- WHEREAS, the Legislative Council has provided the opportunity to present the Executive Branch's the Chairman to Administrative Plan as mandated by the Constitution of the Tohono O'Odham Nation by the following Memorandums attached and dated:
 - January 11, 1988

 - November 9, 1988 December 01, 1988 December 19, 1988; and
- WHEREAS, the above mentioned Memorandums confirms the Legislative Branch's efforts to cooperate with the Executive Branch in reviewing and adopting the Administrative Plan which is a constitutional requirement and crucial to the administration and management of the government.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby rejects the Administrative Plan because the content does not contain enough detail to clarify the manner in which the government is to be administered.

The foregoing Resolution was passed by the Tohono O'odham Council on the 4th. day of January , 1989 at a meeting at which a quorum was present with a vote of 1,416.5 for; -0- against; 223.5 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1 (1) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
