

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rejection of Executive Branch's Administrative Plan)

RES. NO. 04-89

1 WHEREAS, the Legislative Council on January 4, 1989 reviewed and
2 rejected the Administrative Plan submitted by the
3 Executive Branch; and

4 WHEREAS, the basis for rejecting the Administrative Plan is
5 because it does not contain enough details to clarify
6 the manner in which the government is to be administered
7 and the failure on the part of the Chairman of the
8 Tohono O'Odham Nation to appear before the Legislative
9 Council to present the Administrative Plan; and

10 WHEREAS, the Legislative Council has provided the opportunity to
11 the Chairman to present the Executive Branch's
12 Administrative Plan as mandated by the Constitution of
13 the Tohono O'Odham Nation by the following Memorandums
14 attached and dated:

- 15 - January 11, 1988
- 16 - November 9, 1988
- 17 - December 01, 1988
- 18 - December 19, 1988 ; and

19 WHEREAS, the above mentioned Memorandums confirms the Legislative
20 Branch's efforts to cooperate with the Executive Branch
21 in reviewing and adopting the Administrative Plan which
22 is a constitutional requirement and crucial to the
23 administration and management of the government.

24 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
25 Council that it hereby rejects the Administrative Plan
26 because the content does not contain enough detail to
27 clarify the manner in which the government is to be
28 administered.

29 The foregoing Resolution was passed by the Tohono O'odham Council
30 on the 4th day of January, 1989 at a meeting at which a quorum
31 was present with a vote of 1,416.5 for; -0- against; 223.5 not
32 voting; and 01 absent, pursuant to the powers vested in the
Council by Section 1 (1) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
