

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(P.L. 100-485 The Family Support Act of 1988)

RES. NO. 100-89

1 WHEREAS, Public Law 100-485, the Family Support Act of 1988, was
2 enacted into law on October 13, 1988 to revise the AFDC
3 Program to emphasize work, child support, and family
4 benefits, to amend Title IV of the Social Security Act
5 to encourage and assist needy children and parents under
6 the new program to obtain the education, training and
7 employment needed to avoid long term welfare
8 dependence; and

9 WHEREAS, the Family Support Act of 1988 creates a new AFDC
10 education, training and employment program, known as Job
11 Opportunities and Basic Skills Training Program (JOBS);
12 and

13 WHEREAS, included in the Family Support Act is a provision which
14 allows the Tohono O'odham Nation to request the Depart-
15 ment of Health and Human Services (DHHS) for direct
16 funding to conduct a JOBS program; and

17 WHEREAS, the JTPA Program has submitted for review and approval,
18 a Notice of Intent to apply for JOBS Program funds under
19 the Family Support Act of 1988 in the amount of \$43,870.

20 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legis-
21 lative Council does hereby approve the submission of the
22 Notice of Intent to apply for JOBS Program funds under
23 the Family Support Act of 1988.

24 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
25 that the Tohono O'odham Nation's Officials, to wit: the
26 Chairman, Vice Chairman and any designated official are
27 hereby authorized to negotiate and execute the grant,
28 provided however, that any amendments affecting the
29 funding or funding levels of the grant shall be
30 submitted to further prior approval by this Council.

31 The foregoing Resolution was passed by the Tohono O'odham Council
32 on the 12th day of April, 1989 at a meeting at which a quorum
was present with a vote of 1,512.0 for; -0- against; -0- not
voting; and 128.0 (06) absent, pursuant to the powers vested in
the Council by Section 1 (f) of Article VI of the Constitution
of the Tohono O'odham Nation, adopted by the Tohono O'odham

1 Nation on January 18, 1986, and approved by the Acting Deputy
2 Assistant Secretary - Indian Affairs (Operations) on March 6,
3 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
4 Stat. 984).
