

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Program Year 89 Title IV ACP/Training Grant in the
amount of \$515,211.00)

RES. NO. 103-89

1 WHEREAS, the Job Training Partnership Act (JTPA) was enacted into
2 law in 1982 replacing the Comprehensive Employment
3 Training Act (CETA); and

4 WHEREAS, funding is made available to state and tribal govern-
5 ments to establish programs for improving the employment
6 prospects of eligible persons through the designation of
7 service delivery areas; and

8 WHEREAS, the Nation is entitled to JTPA funds to develop a net-
9 work of employment training programs throughout the
10 Nation; and

11 WHEREAS, the Indian Reservations in Arizona have been designated
12 as service delivery areas and are eligible to receive
13 Federal JTPA funds; and

14 WHEREAS, the Tohono O'odham Nation JTPA Programs may apply for
15 Federal JTPA funds pursuant to Agreement with the
16 Department of Labor.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
18 Council that it hereby approves the grant with the
19 Department of Labor for the delivery of JTPA Services on
20 the Tohono O'odham Reservation in the amount of
21 \$515,211.

22 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
23 that the Tohono O'odham Nation will not fund or operate
24 the program in the interim while negotiations are still
25 being conducted and no executed grant has been awarded
26 by the Department of Labor.

27 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
28 that the Tohono O'odham Nation's Officials, to wit: The
29 Chairman, Vice Chairman and any designated official are
30 hereby authorized to negotiate and execute the grant,
31 provided, however, that any amendments affecting the
32 funding or funding levels of this grant shall be
submitted for further prior approval by this Council.

1 The foregoing Resolution was passed by the Tohono O'odham Council
2 on the 18th day of April, 1989 at a meeting at which a quorum
3 was present with a vote of 1,640.0 for; -0- against; -0-
4 not voting; and 03 absent, pursuant to the powers vested in the
5 Council by Section 1 (f) of Article VI of the Constitution of
6 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
7 on January 18, 1986, and approved by the Acting Deputy Assistant
8 Secretary - Indian Affairs (Operations) on March 6, 1986, pur-
9 suant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
