

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Title II - Family Preservation Project
Budget Amendment)

RES. NO. 112-89

1 WHEREAS, the Tohono O'Odham Social Service Department did submit
2 an application for a three year Title II Grant to
3 develop and implement a Family Preservation Project; and

4 WHEREAS, the Tohono O'Odham Nation has been awarded a grant for
5 \$80,000.00 to operate the Family Preservation Project;
6 and

7 WHEREAS, any amendment affecting the funding or funding levels of
8 the grant shall be submitted for review and approval by
9 the Tohono O'Odham Legislative Council; and

10 WHEREAS, an amendment has been submitted for review and approval
11 by the Tohono O'Odham Social Services Department.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legisla-
13 tive Council does hereby approve the amendment to the
14 Family Preservation Project.

15 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
16 that the Tohono O'Odham Nation's Officials, to wit: the
17 Chairman, Vice Chairman and any designated official are
18 hereby authorized to negotiate and execute the grant,
19 provided however, that any amendments affecting the
20 funding or funding levels of the grant shall be
21 submitted for further prior approval by this Council.

22 The foregoing Resolution was passed by the Tohono O'odham Council
23 on the 24th. day of April, 1989 at a meeting at which a quorum
24 was present with a vote of 1,391.5 for; -0- against; 120.5 not
25 voting; and 128.0 (5) absent, pursuant to the powers vested in
26 the Council by Section 1 (f) of Article VI of the Constitution
27 of the Tohono O'odham Nation, adopted by the Tohono O'odham
28 Nation on January 18, 1986, and approved by the Acting Deputy
29 Assistant Secretary - Indian Affairs (Operations) on March 6,
30 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
31 Stat. 984).
