

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Weatherization Assistance)

RES. NO. 113-89

1 WHEREAS, Block Grant applications have been made available for  
2 tribal grants for FY 1990 through the State of Arizona,  
3 Department of Commerce for Weatherization Programs; and

4 WHEREAS, the Weatherization Assistance is available to the Tohono  
5 O'Odham Nation and the Tohono O'Odham Nation does meet  
6 the eligibility requirements; and

7 WHEREAS, it is in the best interest of the Tohono O'Odham Nation  
8 to apply for FY 1990 Weatherization Assistance; and

9 WHEREAS, the Tohono O'Odham Nation believes that it will satisfy  
10 the eligibility criteria set forth in the funding and  
11 reporting regulations.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legisla-  
13 tive Council does hereby authorize the officials of the  
14 Tohono O'Odham Nation to submit a request for Weatheri-  
15 zation Assistance funding from the State of Arizona,  
16 Department of Commerce.

17 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
18 that the Tohono O'Odham Nation's Officials, to wit: the  
19 Chairman, Vice Chairman and any designated official are  
20 hereby authorized to negotiate and execute the grants or  
21 contracts, provided however, that any amendments  
22 affecting the funding or funding levels of the grants or  
23 contracts shall be submitted for further prior approval  
24 by this Council.

25 The foregoing Resolution was passed by the Tohono O'odham Council  
26 on the 24th day of April, 1989 at a meeting at which a quorum  
27 was present with a vote of 1,271.0 for; -0- against; 241.0 not  
28 voting; and 128.0 (5) absent, pursuant to the powers vested in  
29 the Council by Section 1 (f) of Article VI of the Constitution  
of the Tohono O'odham Nation, adopted by the Tohono O'odham  
Nation on January 18, 1986, and approved by the Acting Deputy  
Assistant Secretary -Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
Stat. 984).
