

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY '88 Low Income Energy Assistance)

RES. NO. 114-89

1 WHEREAS, Low Income Energy Assistance Grants have been made  
2 available for the Tohono O'odham Nation for the duration  
3 of 1988 through the State of Arizona, Department of  
4 Economic Security; and

5 WHEREAS, the Tohono O'odham Nation does meet the eligibility  
6 requirements; and

7 WHEREAS, it is in the best interest of the Tohono O'odham Nation  
8 to apply for FY 1988 Low Income Energy Assistance to  
9 assist needy families with utility bills; and

10 WHEREAS, the Tohono O'odham Nation believes that it will satisfy  
11 the eligibility criteria set forth in the funding and  
12 reporting regulations.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legisla-  
14 tive Council does hereby authorize the officials of the  
15 Tohono O'odham Nation to submit a request for Low Income  
16 Energy Assistance funding from the State of Arizona,  
17 Department of Economic Security.

18 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
19 that the Tohono O'odham Nation's Officials, to wit: The  
20 Chairman, Vice Chairman and any designated official are  
21 hereby authorized to negotiate and execute the grants or  
22 contracts provided, however, that any amendments  
23 affecting the funding or funding levels of the grants or  
24 contracts shall be submitted for further prior approval  
25 by this Council.

26 The foregoing Resolution was passed by the Tohono O'odham Council  
27 on the 24th. day of April, 1989 at a meeting at which a quorum  
28 was present with a vote of 1,512.0 for; -0- against; -0- not  
29 voting; and 128.0 (04) absent, pursuant to the powers vested in  
30 the Council by Section 1 (f) of Article VI of the Constitution  
31 of the Tohono O'odham Nation, adopted by the Tohono O'odham  
32 Nation on January 18, 1986, and approved by the Acting Deputy  
Assistant Secretary -Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
Stat. 984).
