

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY '89 Low Income Energy Assistance)

RES. NO. 115-89

1 WHEREAS, Low Income Energy Assistance Grants have been made
2 available for the Tohono O'odham Nation for the duration
3 of 1989 through the State of Arizona, Department of
4 Economic Security, Low Income Energy Assistance Program;
5 and

6 WHEREAS, the Tohono O'odham Nation does meet the eligibility
7 requirements; and

8 WHEREAS, it is in the best interest of the Tohono O'odham Nation
9 to apply for FY 1989 Low Income Energy Assistance to
10 assist needy families with utility bills; and

11 WHEREAS, the Tohono O'odham Nation believes that it will satisfy
12 the eligibility criteria set forth in the funding and
13 reporting regulations.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legisla-
15 tive Council does hereby authorize the officials of the
16 Tohono O'odham Nation to submit a request for Low Income
17 Energy Assistance funding from the State of Arizona,
18 Department of Economic Security.

19 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
20 that the Tohono O'odham Nation's Officials, to wit: The
21 Chairman, Vice Chairman and any designated official are
22 hereby authorized to negotiate and execute the grants or
23 contracts provided, however, that any amendments
24 affecting the funding or funding levels of the grants or
25 contracts shall be submitted for further prior approval
26 by this Council.

27 The foregoing Resolution was passed by the Tohono O'odham Council
28 on the 24th. day of April, 1989 at a meeting at which a quorum
29 was present with a vote of 1,512.0 for; -0- against; -0- not
30 voting; and 128.0 (04) absent, pursuant to the powers vested in
31 the Council by Section 1 (f) of Article VI of the Constitution
32 of the Tohono O'odham Nation, adopted by the Tohono O'odham
Nation on January 18, 1986, and approved by the Acting Deputy
Assistant Secretary -Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
