

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(The Elderly Program Title III)

RES. NO. 121-89

1 WHEREAS, the Tohono O'odham Nation has successfully operated a
2 program for the elderly members of the Nation; and

3 WHEREAS, funding for the operation of the Elderly Program has
4 been possible in part by Title III of the Older Amer-
5 ican's Act of 1965 as amended through the administration
6 by the Inter-Tribal Council of Arizona; and

7 WHEREAS, the Elderly Program has prepared a proposal for FY '90
8 for Title III funding to provide nutritional and social
9 support services to eligible elderly members.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
11 Council that it hereby approves the proposal for Title
12 III funding for the Elderly Program to continue to
13 provide such services it has proposed in light of the
14 requirements and regulations.

15 BE IT FURTHER RESOLVED that the duration of this grant will be
16 from July 01, 1989 through June 30, 1990.

17 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
18 that the Tohono O'odham Nation will not fund or operate
19 the program in the interim while negotiations are still
20 being conducted and no executed grant has been awarded
21 by the Inter-Tribal Council of Arizona.

22 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
23 that the Tohono O'odham Nation's Officials, to wit: the
24 Chairman, Vice Chairman and any designated official are
25 hereby authorized to negotiate and execute the grant,
26 provided, however, that any amendments affecting the
27 funding or funding levels of this grant shall be sub-
28 mitted for further prior approval by this Council.

29 The foregoing Resolution was passed by the Tohono O'odham Council
30 on the 24th. day of April, 1989 at a meeting at which a quorum
31 was present with a vote of 1,512.0 for; -0- against; -0- not
32 voting; and 128.0 (04) absent, pursuant to the powers vested in
the Council by Section 1 (f) of Article VI of the Constitution
of the Tohono O'odham Nation, adopted by the Tohono O'odham
Nation on January 18, 1986, and approved by the Acting Deputy
Assistant Secretary-Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
