

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Bilingual Educational Budget Amendment)

RES. NO. 125-89

1 WHEREAS, the Tohono O'odham Title VII Bilingual Education Program
2 did submit a budget for second year funding under a
3 three (3) year grant with the U.S. Department of Educa-
4 tion, Office of Bilingual Education and Minority
5 Languages Office; and

6 WHEREAS, the Tohono O'odham Nation did negotiate and has been
7 awarded a grant for \$199,950.00 to operate the Bilingual
8 Education Program; and

9 WHEREAS, any amendments affecting the funding or funding levels
10 of the grant shall be submitted for review and approval
11 by the Tohono O'odham Legislative Council; and

12 WHEREAS, an amendment has been submitted for review and approval
13 by the Bilingual Education Program.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legisla-
15 tive Council does hereby approve the amendment to the
16 Bilingual Education Program.

17 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
18 that the Tohono O'odham Nation's Officials, to wit: the
19 Chairman, Vice Chairman and any designated official are
20 hereby authorized to negotiate and execute the grant,
21 provided, however, that any amendments affecting the
22 funding or funding levels of this grant shall be
23 submitted for further prior approval by this Council.

24 The foregoing Resolution was passed by the Tohono O'odham Council
25 on the 24th. day of April, 1989 at a meeting at which a quorum
26 was present with a vote of 1,512.0 for; -0- against; -0- not
27 voting; and 128.0 (04) absent, pursuant to the powers vested in
28 the Council by Section 1 (f) of Article VI of the Constitution
29 of the Tohono O'odham Nation, adopted by the Tohono O'odham
30 Nation on January 18, 1986, and approved by the Acting Deputy
31 Assistant Secretary -Indian Affairs (Operations) on March 6,
32 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
