3 WHEREAS, applications for enrollment as members of the Tohono
4 O'Odham Nation has been filed by or on behalf of:

8 WHEREAS, the Enrollment Committee has reviewed the applications
9 and has recommended that the applications be denied
10 because the applicants failed to establish the following
11 membership requirement(s): TOHONO O'ODHAM CONSTITUTION,
12 ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

13 WHEREAS, the applications has come on for hearing before this
14 Council; and

15 WHEREAS, the Enrollment Committee did serve written notice of its
16 recommendation to reject the applications and of this
17 hearing, as required by Section 2, Article VI of the
18 Enrollment Ordinance, upon the person(s) who filed the
19 application(s) and such person(s) was present at this
20 hearing; and

21 WHEREAS, the Tohono O'Odham Council has reviewed all of the
22 evidence presented and from such evidence finds that the
23 applicant(s) has failed to establish the foregoing
24 membership requirements.

25 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that
26 it does hereby determine that the application(s) of:

29 Ruperto Salcido-Soto

30 for enrollment as members of the Tohono O'odham Nation
31 are hereby rejected.

32 BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham
Nation shall issue a Certification of Final



4 in accordance with the provisions under section 1 and 2
5 Article IIII of the Enrollment Ordinance.

6 The foregoing resolution was DEFEATED by the Tohono O'odham
7 Council on the 1st day of May, 1989, at a meeting at which a
8 quorum was present with a vote of 361.0 for; 1,110.0 against;
9 -0- not voting; and 169.0 (10) absent; pursuant to the powers
10 vested in the Council by Article II and Section 1 (h) of Article
11 VI of the Constitution of the Tohono O'odham Nation, adopted by
12 the Tohono O'Odham Nation on January 18, 1986, and approved by
13 the Acting Deputy Assistant Secretary - Indian Affairs
14 (Operations) on March 6, 1986, pursuant to Section 16 of the Act
15 of June 18, 1934 (48 Stat. 984).
